The reporting person disclaims beneficial ownership of the Issuer's securities owned by the Rickert Family, Limited Partnership, except to the extent of her pecuniary interest and this filing should not be construed as an admission that the reporting person is the beneficial owner of these securities. Shares acquired on February 17, 2016 were awarded as compensation for service as a director of PEN Inc. Share total in Column 5 of Table 1 reflects reverse split that was effective January 26, 2016.
