Explanation of Responses:

(1) Of the total holdings, 11,924 shares of Class B common stock are held directly by the reporting person, 464,256 shares of Class B common stock and 43,910 shares of Class A common stock are held indirectly through Rickert Family, Limited Partnership. The Class B common stock is convertible share for share at any time at holder's option into Class A common stock of issuer and is subject to mandatory conversion under certain circumstances.

Remarks:

1,392,768 shares of Class B common stock and 131,731 shares of Class A common stock are held by Rickert Family, Limited Partnership an entity for which Mr. Rickert is the general partner and has sole voting and dispositive control. Mr. Rickert disclaims beneficial ownership of two-thirds of the shares held by the partnership for which he does not have pecuniary interest and this filing should not be construed as an admission that the reporting person is the beneficial owner of these securities.
